- 1. Opening of meeting and welcome; Eileen Fauster chaired the meeting.
- 2. Called to order and approval of Agenda by Sunny Tang. Seconded by Patrick Wu.
- 3. Approval of previous minutes, motioned by Eileen Fauster and seconded by Patrick Wu.
- 4. Nomination and election of the following for a 2 year term:
 - Peter Lin, VP Marketing, in charge of website management
 - Alan Tang, VP Competition
 - Daniel Yan, VP Administration

Elected last year and active for one more year of their term: President – Eileen Fauster, VP Finance – Patrick Wu, VP Technical – Colin Yung.

- 5. Financial report, ending December 31, 2014, was presented by Patrick Wu.
 - Slight deficient of \$1,025.54 for 2014
 - Half of PSO fees collected by PSOs is remitted to WushuCanada; the other half is retained by the PSOs.
 - Of the membership fees collected from the schools (\$2,450); half goes to WushuCanada.
 - Donation from Sammy Wan of \$3,000, which will be used to purchase the National Wushu Team uniforms.
 - Grading proves to be a high earner for WushuOntario; \$4,100 earned in 2014, which will
 continue this year in 2015.
- 6. Amendment of membership fee

\$100 for 3 years membership of recreational club.

Lifetime membership is now available for general individual members, including the recreational athletes and volunteers.

Lifetime membership is NOT available for Level 2 club membership.

- 7. President's report Regarding athlete participation at the 13th World Wushu Championships, taking place from November 11th to 18th, 2015 in Jakarta, Indonesia
 - 8 athletes for Taolu (4 male, 4 female) and 3 sanda athletes attending,, among them, 3 are coming from Ontario.
 - The entire 13th World Wushu Championships will be televised
 - The 2017 University Games, organized by the Sport Accord, may again include Wushu. This will be determined by the Wushu Executive Committee in Jakarta this month. The international University Games are not really recognized by the Canadian university system. (ASIDE: Eileen to investigate: Learn more about the University Games what recognitions does it have, in relation

to CIAU? What are their standards, their history, their aims? Why/how do they encourage students to compete in university games? We need to adjust our marketing accordingly.)

8. Other business

- Over the coming months, we need to re-organize how we run our competitions in the future, especially about whether we want to expand the Taiji to 2 days, as they take up a lot of time. A final competition agenda must be prepared well in advance, so that Taiji athletes can determine which events to compete in, as per the schedule.
- For the Wushu Taolu competition, do we want to have an international event as time is the great restraint? If we want to make it bigger, then recreational athletes pay a small fee to gain experience of being in a national competition (with lower level judges), while the national level competitors pay a higher fee with international judges, to enhance their high-end experience. We have to look at schools which have no provincial or national aspirations, charging these schools a smaller fee. These Level 1 schools pay \$100 for 3 years and get their name listed on the Wushu Ontario website, for ease of recognition.
- We need further discussion regarding a wushu university scholarship, to encourage high level athletes to continue training wushu into their university years (from ages 18-26).
- how do we attract more recreational high-school, recreational elementary school children, how
 do we retain university level athletes. How do we encourage the wushu athletes in
 Saskatchewan to attend the national competition, as they know they are not as strong as the
 wushu athletes from Alberta, BC and Ontario.
- 9. Next meeting to be scheduled for December to prepare our 2016 business plan. Emails within the next 3 weeks will confirm the date.
